These laws stem from the 1917 Espionage Act, conceived during the height of the African anti-imperialist movement led by Marcus Garvey, and were created to crush anti-colonial and anti-imperialist struggle.

“Foreign agent” charges have long been used to criminalize constitutionally protected speech by African leaders, from W.E.B. DuBois to Chairman Omali Yeshitela.

The bogus prosecution of the Uhuru 3 exposed these statutes as political weapons; their acquittal on “foreign agent” charges dealt a major blow to government efforts to silence the African Liberation Movement.

The Uhuru 3 were convicted of “conspiracy to act as foreign agents” despite being acquitted of being foreign agents, revealing the conspiracy law as a tool of repression.

These laws threaten civil liberties and the First Amendment; Hands Off Uhuru calls on all defenders of democracy to join the fight to repeal them and defend free speech.
